### **4.1 Description of first-aid measures**

<b>General advice</b>	Immediate medical attention is required.
<b>Eye contact</b>	Keep eye wide open while rinsing. Immediate medical attention is required. Rinse immediately with plenty of water, also under the eyelids, for at least 15 minutes. Do not rub affected area.
<b>Skin contact</b>	Immediate medical attention is required. Wash off immediately with soap and plenty of water. Remove all contaminated clothes and shoes.
<b>Inhalation</b>	Move to fresh air. Call a physician or poison control center immediately. If not breathing, give artificial respiration. If breathing is difficult, give oxygen.
<b>Ingestion</b>	Do NOT induce vomiting. Never give anything by mouth to an unconscious person. Drink plenty of water. Immediate medical attention is required. Remove from exposure, lie down. Clean mouth with water and drink afterwards plenty of water. Call a physician or poison control center immediately.

## **6. Accidental Release Measures**

### 6.1 Personal precautions, protective equipment and emergency procedures

**Methods for Containment** Prevent further leakage or spillage if safe to do so. Cover powder spill with plastic sheet or tarp to minimize spreading. Dike far ahead of liquid spill for later disposal.

**Methods for cleaning up** Dike far ahead of liquid spill for later disposal. Soak up with inert absorbent material. Take up mechanically and collect in suitable container for disposal. Clean contaminated surface thoroughly. Prevent product from entering drains. Dam up. After cleaning, flush away traces with water.

## **7. Handling and storage**

### 7.1 Precautions for safe handling

**Advice on safe handling** Avoid contact with skin, eyes and clothing. Wear personal protective equipment. Ensure adequate ventilation. Avoid contact with skin and eyes. In case of insufficient ventilation, wear suitable respiratory equipment. Handle product only in closed system or provide appropriate exhaust ventilation at machinery.
